Sorry not to have been in touch about this: I have been massively tied up on the other case.

9 March 2009 is definite. Also I would definitely want Harriet but that is dependant upon us having funding. Certainly no other counsel will be involved and Harriet has first call.

The problem is that none of the clients has so far co-operated with regard to requests to complete funding documentation for legal aid. I must admit though that I have been so tied up that I have not managed to chase them up again lately. I am about to return to AVMA to ask for their assistance.

Its a difficult call. I assume we have a good chance of funding but in event we did not get it I understand that Harriet could do two weeks pro-bono; more than that would be unreasonable to expect of her.

It would be good if you can keep 9 March 2009 onwards for the inquest clear but if you are looking at a civil claim I am happy for you to take a gamble and double book - even if it meant ending up Harriet doing the inquest and needing someone else to cover part of it for her so she can take in a trial.
