Many thanks for the update.

I must admit prescribing a range of a drug with serious side -effects at a range of 20 - 200 (a factor of ten) and delegating the decision for dose to less experienced and less trained people seems to have an air of wrecklessness about it. I think also just because these patients were near the end of their lives, it seems a bit harsh to have a regime that is "careless" about shortening them further.

If you can push the lines of: -

- inappropriate dosages and routes of administration (not a matter of bodies of medical opinion but in fact not following guidelines)
- lack of distinction re palliative treatment and rehabilitation
- not tailoring the drug regime to the needs of individual patients
- unjustified risk taking
- contributing to cause of death as far as you can argue it.

If you can submit that there should be a UL verdict that would be great but I understand the difficulties.

How about asking Dr Barton if she enjoyed killing people or was she just incompetant! - do n't worry - you do not really have to ask that!!
