I have put in an application for public funding under "exceptional circumstances" but unfortunately I have litte hope that this will result in the help that is needed - hence the letter really giving the realistic position so at least you have the opportunity to try to make you own private arrangements.

It is still our intention to send a "watching brief" for the generic stage so at least if the position changes we will know about it and it gives some chance of reacting to it.

Disappointing I know. I am sorry to be the bearer of grim news.

I hope that your time abroad is going well. I am sure we will meet up at some point, most likely at the inquest and I look forward to speaking with you again then. I will of course let you know immediately should anything change about funding but you should not assume that a change is at all likely I am afraid.
