



HM Coroner findings re Operation Rochester inquests

The Coroner in addressing the jury asked them to consider three questions in relation to the death of each individual person.

1. Did the administration of any medication contribute more than minimally or negligibly to the death of the deceased?

If the answer was No then that was the end of the matter. If the answer was yes then they could proceed to question two.

2. Was that medication given for therapeutic purposes?

If the answer was yes then they could proceed to question three.

3. Was that medication appropriate for the condition or symptoms from which the deceased was suffering?

In three cases the jury reached a conclusion that the administration of medicine contributed more than minimally or negligibly to the death of the deceased. The medicine however was given for therapeutic purposes but it was not appropriate for the condition or symptoms from which the deceased was suffering.

In two cases the jury reached a conclusion that the administration of medicine contributed more than minimally or negligibly to the death of the deceased. The medicine however was given for therapeutic purposes but it was appropriate for the condition or symptoms from which the deceased was suffering
