Re: Gosport War Memorial Hospital

In June 2000 I made an official complaint to the Portsmouth Health Care Trust about the treatment my husband received whilst a patient in the Sultan Ward of the Gosport War Memorial Hospital.

After my phoning weekly I eventually received a 'luke warm' apology from the Portsmouth Health Care Trust. I then attended the official investigation by the Commission for Health Improvement to voice my concerns in October/November 2001, whence I received the CHI report in June 2002. I am far from satisfied with the lack of follow up after this report was published as it only clarifies my suspicions.

My husband, who thankfully is still alive, was transferred to the War Memorial from Royal Hospital Haslar mid April 2000. He was suffering from a particularly nasty flare up of osteo arthritis. He also had severe painful swelling of all joints. He was transferred to the War Memorial for complete rest. I visited him twice daily and was not at all impressed by the standard of care he received. In hindsight I never saw him eat of drink. Meals were left at the foot of the bed on the over bed tray and he was in too much pain to reach it.

In brief, on 9th May 2000 he was deeply unconscious. An emergency Doctor was called, who after taking five hours to arrive, diagnosed a severe mid brain stroke. I queried this but was assured that that was what had happened. Consequently my Husband was transferred back to Royal Hospital Haslar, where they confirmed my husband had **not** had a stroke, but an analgesic overdose and was suffering sever dehydration, which was causing him to hallucinate badly.

After a few days of care, Haslar were no longer unable to provide a high dependency bed and said that my husband must return to the War Memorial Hospital for rehabilitation. I refused this transfer and took my husband home. It was over a year before my husband recovered from this terrible ordeal.



I am now aware of several other cases which are similar to mine, unfortunately ours would appear to be the only one where a relative has survived. I would ask that this matter and the general care that was provided at the Gosport War Memorial Hospital during this time is investigated.

Re: Gosport War Memorial Hospital

I am writing in respect of the investigation into the care of elderly patients at the Gosport War Memorial Hospital.

In April 2000 my Husband was transferred from the Royal Hospital Haslar to the War Memorial for respite as he was suffering from osteo arthritis, which had resulted in bursitis and gout. During my visits I became increasingly bothered about the lack of care shown to my Husband. Meals were left at the foot of the bed on the over bed tray and he was in too much pain to reach it. They were then taken away and I was told that he had refused food.

On 9th May 2000 he fell into unconsciousness and an emergency Doctor was called, who after taking five hours to arrive, diagnosed a severe mid brain stroke. I queried this but was assured that this was what had happened. Consequently my Husband was transferred back to Royal Hospital Haslar, where they confirmed my husband had **not** had a stroke, but an analgesic overdose and was suffering sever dehydration, which was causing him to hallucinate badly. After a few days Haslar suggested that my Husband return to the Gosport War Memorial Hospital for rehabilitation, as they could no longer provide him with the high dependency bed he was occupying. I refused this transfer and took my husband home.

It took my husband a year to recover from this terrible experience. I have made an official complaint to the Portsmouth Health Care Trust and later attended the official investigation by the Commission for Health Improvement to voice my concerns in October/November 2001. Since receiving the CHI report in June 2002 I am dissatisfied with the lack of follow up. I am now aware of other cases similar to mine and feel lucky in knowing that my husband was able to survive his ordeal. However I believe that without further investigation, with a thorough gathering of evidence, the happenings at the Gosport War Memorial remain a public injustice.
