I am writing in response to your letter dated 19<sup>th</sup> August 2002. I was very shocked to read your response regarding the death of my dear Husband at the Gosport War Memorial. Am I to understand that you have totally disregarded my letter to you regarding the unlawful killing of my husband?

I also cannot understand your statement that it is not in the public interest to bring charges to the individuals at the hospital; this is already in the public domain with the damning report by the Commission for Health Improvement. Are you saying that is perfectly alright for the doctor concerned to practice the Wessex guidelines on patients that are not termally ill and if this is the case why is it not happening today? A doctor of 25 years knew exactly what she was doing and she is now being protected my the Police, this is a total disgrace. If the Hampshire Constabulary investigate they will find the evidence needed to get this doctor into court.

I wrote in my letter to you that my late husband was only in the Gosport War Memorial Hospital 18 hours for rehabilitation and the events surrounding his death are very suspicious and since that day, myself and my family have found it very difficult to move forward.

I am horrified with your response and I will continue my fight for justice.

Thank you for your letter dated 16<sup>th</sup> August, 2002 concerning the sad death of your husband at the Gosport War Memorial Hospital on 27<sup>th</sup> April, 1999. You are clearly already aware of the CHI Report and also the fact that the Police have submitted evidence to the Crown Prosecution Service. We are of the view that it is not in the public interest to bring any charges against individuals at the hospital at this time. Having obviously looked closely at the evidence, and as you will no doubt be aware, it would need to be very persuasive in nature if it were to prove that doctors at the hospital had been criminally negligent.

Nonetheless, I am currently in correspondence with a number of other persons concerning this matter and am seeking to re-submit all the evidence to the Crown Prosecution Service, along with other police reports and the CHI Report. When I have the response I will obviously liaise with you again. Please contact me if I can be of any other assistance in the interim.
