You should by now have received case number 8, that of Geoffrey PACKMAN forwarded to you on the 26th June 2006..

Whilst there are 2 more cases to follow those of Service and Gregory they are not strong cases as indicated in my summary doc of 10th June 2006 and I would suggest are highly unlikely to be prosecuted in the light of expert evidence.

Looking at the evidence I would say that the cases having the most potential for criminal prosecution are:-

SPURGIN

WILSON
