| se Summary: | The original report in this case was submitted to this office in Jant 2001. Mrs Gladys Mabel Richards was a 91 year old in patient at Gosport War Memorial Hospital when she died on 21 August 1998. It alleged that the lack of nursing care and the administration of drugs over period of time via a syringe driver had caused her death. The cruevidence hinges on the conclusions by an expert witness, Profest Livesey who concluded that Mrs Richards was unlawfully killed in his redated 1.11.00. Counsel were briefed to advise on the merits of the care on 19.6.01, a conference took place with Counsel attended by Profest Livesey. It emerged that Professor Livesey was not entirely clear of legal ingredients of Gross Negligence Manslaughter. Professor Livese conclusion was found to be untenable and without support. A full adward was submitted by Counsel on 21 July 2001 and the Officer in Charge of case was informed by Paul Close as to the decision not to prosecute in case. |
