### PETITION TO THE SECRETARY OF STATE FOR HEALTH

We the undersigned do respectfully request the government to:

- 1. Ensure that discrimination of the elderly and vulnerable in the NHS is unlawful.
- 2. Make it unlawful for medical staff to neglect patients needs, withdraw food & liquid or administer drugs that will result in the ending of an individual's life.
- 3. Make compulsory the signing of a legal form by a doctor and patient or the next of kin indicating the agreed course of treatment and administering of drugs.
- 4. Make compulsory the monitoring of diamorphine and similar drugs and that the patient and relatives understand its duel effect.
- 5. Train/retrain medical staff in practical care of and attitudes towards patients.
- 6. Make illegal DNR instructions without the consent of the patient or next of kin.
- 7. Produce a compulsory register of hospital staff who are members of Masonic lodges.
