I am Mary Elizabeth FIELDS and I live at an address known to Hampshire Police.

I retired from the National Health Service where I had been an Auxiliary nurse, due to ill health in 2001.

Between 1986 and 1988 I was a Ward Aide at the Royal Hospital Haslar. This was then a purely military hospital and my role was I suppose similar to an auxiliary nurse.

In 1988 I worked at the Redcliffe Annexe in Avenue Road, Gosport as an Auxiliary Nurse which catered for some 23 patients in long term elderly care.

In 1994 the whole annexe was transferred to Gosport War Memorial Hospital and became Dryad Ward. I worked there in the same capacity on night duty where I did three nights per week.

At the same time I worked for Wren Nursing Agency at Porchester, where I was employed as a night agency auxiliary nurse at both Queen Alexandra and St Mary's Hospital's in Portsmouth and also in local rest homes.

I was absent from work during 1995 due to ill health. I resumed my role on Dryad Ward

In 2000 I again suffered from ill health and I was medically retired in 2001.

I have no medical qualifications, but attended various courses, including manual handling and a drugs course where we were shown how and where to witness the administration of drugs by a

trained nurse. As an Auxiliary Nurse I was not allowed to administer drugs.

I received no training in the administration of syringe drivers.

I do not know what the Wessex protocols are

I know what the named nurse is but I don't think it was used when I was nursing.

With regard to the nursing notes, I would complete them at the time if it was important,

however if it was general then they would be completed later.

I worked three nights per week from 2000 to 0745.

I often saw Dr BARTON on the ward before I left for home after a night shift but I never

accompanied her on a ward round.

Dr BARTON would come onto the ward on occasions when I was working if a particular

patient was poorly.

I do not recognise the term, all nursing care.

The term TLC, tender loving care, I recognise as being used when a patient was coming to the

end of their life, when they should be made as comfortable as possible.

I have not heard the term, I am happy for staff to verify death at GWMH; although it is

something I have heard whilst working as an agency nurse at rest homes.

I have been asked to detail my involvement in the care and treatment of Geoffrey PACKMAN. I

do not recall this patient even after viewing a photograph of him, but from referral to entries in
