Hampshire Police issued the following press release today:

Hampshire Constabulary detectives from Operation Rochester, investigating the deaths of 90 elderly patients at Gosport War Memorial Hospital before 2002, have released 80 of 90 cases under police investigation and have informed all the families accordingly.

Detective Superintendent David Williams said: "Following extensive investigation and reference to medical experts it has been established that there has been no criminal negligence in respect of the 80 cases. However, issues have been raised in respect of the standard of care in some of those cases which have been forwarded to the General Medical Council and Nursing and Midwifery Council for their attention.

"We continue to fully investigate the 10 remaining complaints made to us which are now at an extremely advanced stage and have received considerable co-operation from the Fareham and Gosport Primary Care Trust in facilitating interviews with staff.

"This investigation has been necessarily detailed and thorough, given the complexity of issues. I feel confident that the Crown Prosecution Service has all available evidence upon which to properly consider the determination of the investigation."

We've had a queue of media calls today - Julie's interesting exchange with a BBC journalist is below. Basically we have just said the matter remains under consideration. Can I just check with you that that remains the case please?

I have not been involved in the Hampshire Police's press release and have not received a copy. I did not know any press release was being issued.

From what I have seen on PA, it relates entirely to the police investigation and confirms that the CPS is considering files. PA quite clearly states that files have been sent to the CPS to decide if there is enough evidence. We have not made any decisions yet. No cases have been dropped because no decisions have been made.

As you have been told on several occasions, we will try to keep you informed about what's happening from the CPS point of view. As far as we are concerned, nothing has changed and the case is still under
