2.03.4 Guidelines for the Management of Acute Confusion and Aggression for use in the Department of Elderly Medicine – progress?

Still not resolved. A meeting had recently taken place with Dr A Dowd. She is still unhappy about moving acutely confused or aggressive patients from community hospitals prior to sedation. Revised wording has now been produced and will be subject to review by Dr Dowd. New version to be returned to Dr Reid for approval within PCTs. JJW to take revised wording to PHT.

3.04.4 New Guidelines for approval

a. Guideline for Medical/Pharmaceutical Representatives

Approved but to be generalised prior to being placed on intranet and extranet sites. KH to ensure that she is happy with the revised version from a PCT point of view.

b. Once Daily Gentamicin Administration in Adults

c. Prevention of Sepsis in Asplenic and Hyposplenic Adult Patients

d. New Drug Names

Approved but questions raised concerning education of nursing staff. Agreed to laminate and attach to drug trolleys

- e. Initial Treatment of Fever/Sepsis in neutropenic patients – adults

Approved

- f. Omeprazole Intravenous (IV) Infusion for Bleeding Ulcers

Agreed to review against June Drug and Therapeutics Bulletin to ensure no conflict. Change title to peptic not gastric ulcers. Delete rabeprazole, which is now non-formulary. Revised version to come to Dr Reid for approval prior to going on intranet website.

- g. Pneumonia, community acquired

Approved subject to inclusion of note on renal function for cefuroxime (see wording on Cellulitis Guideline

- h. Treatment of cellulitis

Approved but to be slightly re-formatted to reverse “severe” and “non severe” in line with pneumonia guidelines. In general have less severe/first line before severe/second line.

- i. Drugs with Food and Drinks

Approved but title to be changed to “Timing of medicines administration in relation to food and drink.”

- j. Atypical antipsychotics – Hampshire Partnership NHS Trust

Approved but PD agreed to produce a front sheet. JJW to circulate complete version of Hampshire Partnership Guideline with notes of meeting or by post.
