Clinical governance arrangement with GP's are robust and can be evidenced via the results of the quality and outcomes framework visits and Practice development Target days which pick up risk areas such as Child Protection and risk management and reporting. These were key objectives in the PCT clinical governance development plan.

The PCT supports funding for a clinical governance lead in community pharmacy and a baseline assessment of progress has been undertaken and an action plan developed.

Support to Optometrists and Dentists is less well developed although identified as actions within the CG development plan for the PCT. Baseline assessments have been undertaken and action plans generated although not yet

well' progressed.

Local enhanced servies exist in both Pharmacy and General Practice.

Response to rec'n 17 on page 17.

A Clinical Governace Strategy was developed in 2004 and is attached . However given the recent refocusing of leadership initiative locally and the establishment of and EH and F&G single management team it is likely that the two PCT strategies will be integrated over the coming year.
