Following a Healthcare Commission Clinical Governance Review organisations are required to development an effective Action Plan in response to key areas for action or recommendations outlined in the Healthcare Commission's Report. We anticipate there will be 6 main recommendations arising from the report.

The aim of the day is to agree key high-level actions in response to the main recommendations in the report.

The outcomes of the day will therefore be:

- 1. to agree objectives in response to the key areas for action.
- 2. to agree the tasks and the information required to meet those objectives.
- 3. to identify the measurable outcomes, which will improve patient care, the process is to support them and how these will be monitored.
- to identify the person with lead responsibility within the organisation, for implementing and monitoring the component part of the Action Plan and associated timetables.

The structure of the day will be mainly group work, focused on the principal recommendations and will provide an opportunity for all participants to continue to develop thinking about the areas for review and action. In order to achieve this, each of the groups will be facilitated by one of the executive directors from the PCT and supported by a member of the quality team. This should ensure the group is aware of current related Clinical Governance activities.

The Healthcare Commission is very clear that action plans should contain the following:

- clarity about the action required and accountability
- clear and measurable outcomes, which focus on continuous improvements
- clarity about the systems of monitoring
- clarity about responsibility for monitoring the implementation and outcomes of the action plans
- meet links to the organisation's Clinical Governance Development Plan/s
