

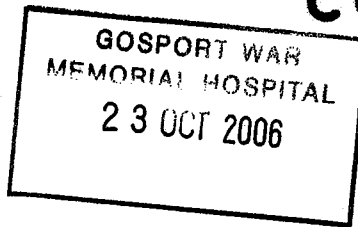

We write further to our formal letter of claim. We are disappointed to note that you have not acknowledged the letter and that you have failed to provide us with your Insurance details within the 21 day period allowed to you under the Personal Injury Pre-Action Protocol.

We would remind you that the Pre-Action Protocol s 3.6. stipulates that

“ The **defendant should reply within 21 calendar days** of the date of posting of the letter identifying the insurer (if any) and, if necessary, identifying specifically any significant omissions from the letter of claim. If there has been no reply by the defendant or insurer within 21 days, the claimant will be entitled to issue proceedings.”

As you have failed to respond within the 21 day period we are instructed by our Client to issue an Application against you to seek disclosure of your Insurance details, to seek your formal decision on the question of liability and to seek disclosure of the documents which we have requested from you in the formal letter of claim.

We are prepared to grant you a further extension of time of 14 days from the date of this letter in which to respond and provide us with your Insurance details. If you do not respond and provide us with your Insurance details within this period, we can confirm that we will issue an application against you. We wish to put you on notice that we will seek an order that you pay the wasted costs of the application.
