Are we able to answer these further questions please? I'm aware that I am on leave from tomorrow for a week and that Code A is away until Thursday - I advised the applicant on Friday that we were consulting with our legal team and would respond early this week.

From your advice would the following draft response be appropriate?

In rejecting my first request for the 1991 Internal management report you place an exemption under Section 31 (c) of the Act. In reaching this decision, can you specifically tell me whether you have established if the report has been disclosed to the Coroner for the forthcoming inquests?

I am advised by our legal counsel that this report forms part of the documentation for the forthcoming inquest and they are still in the process of providing information to the Coroner.

You say that any post-inquest release of this information would have to be considered at a later date. Please could you explain why this cannot be considered now. With the conclusion of the inquests estimated to be just six or seven weeks away, one solution would be to examine releasing information on the day the inquests conclude.

The Public Interest Test undertaken by Hampshire PCT in considering the possible release of the information requested prior to the conclusion of the inquests demonstrated that to release only part of the whole of the information related to these inquests at this stage could:

- project an unbalanced perspective to the public when viewed out of context
- have the potential to influence the Jury
- Impact on the Coroner's role, distracting public attention from the whole of the Inquiry thus impeding his role in achieving a fair verdict
- Discourage witnesses to provide full responses in anticipation of further public release As previously stated Hampshire PCT is willing to reconsider at a future point in time such as at the finalisation of the inquests.
