Clothes worn by other residents. Drawers full of named clothing and hats. Frequently observed raised voices to residents by trained + care staff. Speaking in an unkind manner. Refusal of requests for toilet. Toilet not cleaned for days. Buzzers going for hours, except by family. Call system not answered at night when some requested help to get Holte to toilet. Nobody arrived. In 10 days following collapse. John did not visit Holte's room once to see how she or we were. Constant requests for hearing aids made us feel a nuisance. Holte has been without them for 7 months making communication a slow, quiet session. Unpleasant for anyone.

July Holte fell to the toilet. Found to be very red with small area sore on buttocks. Opened door asked care ass't for clean pad and what was cream is used here or some lotion. Gave large container of E45. Explained I didn't want a moisturiser on moist area. I'm only a C/A! I don't know! Saw Sue RGN through door. Same request. Holte still standing by toilet distressed. Sue brought E45. Explained again. You'll have to wait. if you want something else I'm buying. Wanted, washed nappy, plus pad etc. Walked her back to lounge. Sue came 20 mins later. Saying stores won't close till tomorrow had decanted some diapeone into small pot for Holte's use. I asked care ass'ts to apply some as she was so sure when she next went to the toilet. Took large & small amount of skin
