Dear Mrs/Ms. Hall.

I am in receipt of your letter of the 14th Jan 08 for which I thank you.

I am, of course, more than happy to cooperate with you in any way I can and confirm that I will be available Sept/Oct 08. I will however be out of the country for the second half of May - through to August 14th - so may I suggest that you request anything you need from me before that time, so there is no delay in you receiving anything in good time before Aug/Sept.

I am not familiar with the term "production statement". It looks to me as if it is various sentences taken from a comprehensive statement made during one of the police investigations. I would be pleased if you would clarify this for me as I feel there are several really important parts of the statement that you have not included - but I expect you will use the whole for evidence.

Yes indeed I did give statements for C+I and when their report was published there are several paragraphs with information that came directly from me and they ^{were} used. I can clarify them.

My original statement is lengthy and I need to sit and quietly go through it word for word before I sign the production statement. While I have no new evidence I would specifically like to ensure that you know how I feel about

about facts that need (if not already) to be addressed and noted.

- ① My Mother did not die a natural death.
- ② She was denied her basic rights when fluids and nourishment were withdrawn due to her state of sedation and Dr Barton refused to give her a drip or transfer her - whereas had been verbal accepted back to Hester by her Consultant.
- ③ Because of her dehydration - her kidneys failed.
- ④ The only sips and moisture to her mouth was administered by myself while safe to do so.
- ⑤ As the CHI report states in "Key findings" page 19. Para 1. A protocol existed in 1998 for palliative care prescribing etc etc.
This is ~~an~~ a most important proved point. - probably more damning than much of the other evidence in my opinion
