Rachel,

this is Peta. Mum has been trying to get hold of you but we appreciate you're busy!. She has a copy of notes of Barton's which the Police took copies of dated from 11 August 1998, copied by the Police in 1998 when the Police went to the hospital to investigate.

The copy of the medication sheet Mum was shown of Bartons notes at the hearing is NOT the same.
