INVESTIGATIONS INTO THE GOSPORT WAR MEMORIAL HOSPITAL NEWSLETTER

Thank you to all those who have returned consent forms, indicating the strength of your support for investigations by particular agencies. The general consensus of opinion is, as we thought, that a criminal prosecution ranks highest in your priorities. Our intention, therefore, is to assist the police where possible with the criminal proceedings and thereafter give further considerations to the order of subsequent investigations.

Criminal Prosecution

A meeting took place recently between Hampshire police and the CPS and we have now been informed that the criminal investigation is proceeding. The police intend to draw together a team of experts to examine all future material. This will include experts in Palliative care, Geriatric care and Toxicology. They also intend to liase with Professor Baker. We do need to stress, however, that the preparation for any potential criminal prosecution is likely to take many months.

We should also like to make you aware that discussions between you and anyone else – in particular other families, potential witnesses and the press – may prejudice either the criminal investigation or any proceedings which are brought. We strongly suggest that any information you may give or receive is relayed only to ourselves or directly to the police.

Whilst there is some preparatory work we can do, the police must be allowed to investigate without hindrance. We enclose a letter that has been sent to us by the police to be distributed, which provides details of the new Family Contacts Officer for Operation Rochester.

General Medical Council

For those of you who have made complaints to the GMC, matters are now in hand. However, we wish to make it absolutely clear that GMC proceedings will rank second until the conclusion of any criminal prosecution. If anybody wishes to put forward a further or fresh complaint to the GMC, we would be more than happy to assist you in doing so. It is unlikely to progress far until the conclusion of the police investigation and prosecution process.

Nursing and Midwifery Council

Similarly, if anyone has a specific complaint which relates to a named nurse, we would be willing to discuss this with you further, with a view to helping you submit a formal complaint.

Public Meeting

We should like to arrange another meeting with families once we have further information with which to update you. We intend to hold this on the evening of **Wednesday 5th February 2003**, again at the Solent Hotel, Fareham. We will provide you with further details when available.
