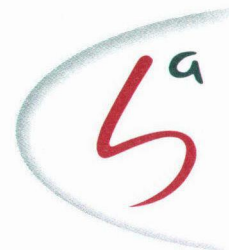

**PROPOSED AGENDA FOR MEETING WITH HAMPSHIRE POLICE 30/09/03**

1. Explain in more detail why further experts are needed. What, specifically, will they be looking at?
2. Why have Field Fisher Waterhouse been instructed? Why are the police not seeking further advice from the CPS lawyers?
3. Why have there still been very few witness statements/accounts taken from all the relatives, particularly when the families have regularly expressed concerns that there are errors/omissions in the medical records?
4. Before decisions are made as to whether to take each case forward, will any experts have been presented with evidence from the families?
5. Why can those families whose cases do not warrant 'further investigation' not be informed of this now? Are these cases going to be looked at again?
6. When families are informed of the outcome of the experts review, they do not want to be told in a letter or by telephone call.
7. Why was there no victim support at the last meeting, given the nature of the information imparted?
8. Any additional queries raised by families.
