Thank you for your letter dated 18 July concerning the CHI report.

You have asked for my views on various issues covered by the report which, alas, are unlikely to carry much relevance as my concerns regarding the presence of intent to dispose of the patients concerned have never really been addressed at all. I am sure you will appreciate that if the Trust is unable to get its act together after all that has been said and done then the Trust itself needs to be scrutinised. I have little doubt that the Gosport War Memorial Hospital is one of the safest and best supervised hospitals in the country at the moment which, it seems to me, the report is seeking to convey.

The intones of your second question are: Can we trust the Trust to remain competent in the future? The answer is I doubt it. As soon as the pressure if off and guards begin to drop it is more than likely that old complacencies will creep in, and in a few years things could be back where they started.

The report paints a glowing picture of what has been achieved as a result of the deaths in the late 1990s as one would expect it should, but glibly sidesteps the root issues as if hiding behind the fact the police have found nothing amiss after their investigation which has been less than competent to say the least.

I read in the local newspaper only last night that the report into the alleged inadequacy of police investigation is being passed to the Chief Constable for decision yet, even now, after all my representations, I for one have still not been interviewed. It seems to me the case is cut and dried whatever the facts, and the Trust will rest cosily behind this.

Unfortunately, the matter will never rest there in the minds of the families concerned, and I have little option to point the finger directly at your office for allowing this to happen in the first place.

I am sorry I cannot be more optimistic or supportive, but I have tried to be honest.

At the media briefing on July 3rd I promised that I would write to you once you had time to read and reflect on the report. There are three main issues I would really value your views on:


- 1. are there any specific questions or queries you have about the content of the report itself?

My name is Lucy Docherty and I am the Chairman of Fareham & Gosport PCT. We are here to discuss the findings of the CHI investigation into services at Gosport War Memorial Hospital. However, before I go any further, let me just make a number of domestic announcements:

Introductions: Mr Ian Piper, Chief Executive of the Trust, Dr Ian Reid, Medical Director, who are sitting with me.

At the end of 2001, following concerns raised by members of the public in respect of the care of some patients at Gosport War Memorial Hospital, the Commission for Health Improvement (CHI) was invited by the then Isle of Wight, Portsmouth and South East Hants Health Authority to conduct a thorough, independent, investigation at the hospital. CHI was asked to look at the issues underlying the complaints, and previous investigations, with the aim of reviewing current practice to ensure that the hospital is providing safe, good quality care for patients today. The report has been published this morning. The purpose of this media briefing is to discuss the report and its conclusions with the press.

We have arranged facilities for any relatives who are here today and wish to speak direct to the media or ourselves after the media briefing is over. There will also be the opportunity for individual interviews. Please let Sue Galley or Rob Dalton know after the questions who you would like to interview but can I stress that this next half hour is for questions from the media.

I will now hand over to Ian Piper who will summarise the content of the report and outline the recommendations and next steps.

There will then be an opportunity for the press to ask questions of the panel.

### STATEMENT FROM IAN PIPER, CHIEF EXECUTIVE, **FAREHAM AND GOSPORT PRIMARY CARE TRUST** 3 JULY 2002

There are a number of points that I would like to raise with you on behalf of Fareham and Gosport Primary Care Trust:

- 1. We welcome this report. It represents in my view one of the most thorough examinations of any community hospital in the country.
- 2. During their investigation, the Commission for Health Improvement team spoke to almost 100 staff, 36 patients' relatives and friends, held interviews with 15 NHS organisations, and undertook a five day visit to Gosport War Memorial Hospital.
- 3. This contributes to my view that this report is fair, rigorous and independent.
- 4. We acknowledge that the last four years have been very difficult and distressing particularly for the families and also the staff at Gosport War Memorial Hospital.
- 5. I am aware that the families raised their concerns so that services would improve and I hope that the publication of the CHI report provides reassurance that this has happened.
- 6. The CHI report highlights some serious concerns about prescribing practices and management systems in 1998.
- 7. The report acknowledges the significant improvements that have been made since 1998. The Trust has:
  - increased nursing and medical staffing,
  - strengthened accountability and supervision arrangements,

- developed a range of training initiatives and
- developed policies, in particular for prescribing and pain management.
- 8. The report also identifies further recommendations to improve services. In some areas work has already started.
- 9. As a new organisation we accept the recommendations in full and will be working with East Hampshire PCT to implement the changes required. We received the report only yesterday, and aim to develop an action plan by the end of August this year.
- 10. One of the first steps we will be taking is to ensure that the relatives are as involved as they wish to be in the plans we draw up to implement the recommendations.
- 11. It is important for the people of Gosport to have confidence in the services provided at Gosport War Memorial Hospital and we believe that the CHI report gives them this reassurance.

## CHI report into Gosport War Memorial Hospital published

The standards of care now available at Gosport War Memorial Hospital have been given a clean bill of health by the Commission for Health Improvement (CHI) following a major review of services by the Government's NHS watchdog.

However, the investigation team made a number of serious criticisms about prescribing practices and management arrangements at the hospital during the late 1990s. The report acknowledged the significant improvements which have been made since then and makes a number of additional recommendations to further improve services.

The investigation followed a number of complaints by the families of patients about standards of care provided for frail elderly people dating back to 1998. The complaints were also investigated by the Police, who decided in February this year not to proceed further with their enquiries.

CHI concluded that, at the time of the deaths, a number of factors prevented the Trust from ensuring good standards of care. They found that prescribing policies were insufficient to govern the use of powerful pain relieving drugs, that a lack of data meant that high levels of prescribing could not be challenged, supervision systems were inadequate and that assessment procedures were not sufficiently thorough.

It stressed that the hospital now had adequate policies and guidelines in place governing drug prescribing and the supervision of clinical staff. It also said it had no significant concerns about the standards of nursing care provided at the hospital now.

Ian Piper, Chief Executive of Fareham and Gosport Primary Care Trust, welcomed the report saying that it represented one of the most thorough examinations of any community hospital in the country and that services were now of a standard that should reassure the people of Gosport.

"As a new organisation, we welcome and accept fully the findings of the report and are pleased that CHI recognised the improvements which have been made in services since the complaints it investigated were made," Ian Piper said.

lan Piper stressed that the complaints and the subsequent CHI investigation had, at all stages, been taken very seriously by the former Portsmouth HealthCare NHS Trust, and said that Fareham and Gosport Primary Care Trust would ensure that lessons learned will not be lost.

"The last few years must have been a period of great anxiety for the families and staff concerned and we remain committed to working with them to further strengthen and improve the services provided at Gosport War Memorial Hospital.

"It is important for the people of Gosport to have confidence in the services provided at the War Memorial Hospital and we believe that the CHI report gives them this reassurance."

#### Note to editors:

- The Commission for Health Improvement is an independent national body covering England and Wales, which supports and oversees the quality of clinical governance in NHS services.
- CHI launched its investigation in October last year, examining the management, provision and the quality of some aspects of health care at Gosport War Memorial Hospital.
- The decision to investigate came from concerns expressed about the use of some medicines, particularly analgesia and levels of sedation, and the culture in which care was provided at the hospital. It also considered responsibility for clinical care and transfer arrangements for patients.
- It did not reinvestigate individual complaints or the actions of specific members of staff.
- Fareham and Gosport and East Hampshire Primary Care Trusts took over responsibility for services for elderly frail people provided at Gosport War Memorial Hospital on April 1st this year. These were previously provided by the former Portsmouth HealthCare NHS Trust.
