I understand under the FOI I an obtain papers from the GMC. On reading and re-reading the transcript of the GMC hearing I notice reference is made to Dr. Barton's statement of 2004. I have a very strong query BEARING IN MIND THAT COMPLAINTS AGAINST Hampshire police were upheld by the PCA in 2001 for investigation failures followed by a complaint upheld on the same basis years later by the IPCC, that the GMC ever received all the reports from the police. I know that when the GMC were waiting for papers on the other cases there was a long delay before they eventually reached the GMC although I was repeatedly told they had been sent. Paul Hylton was involved then. I also note in the Press that the GMC did not know about the situation regarding Bulstrode . Field Fisher Waterhouse were aware - I told them before the hearing and also a member of the GMC staff. I also note that the hearing could not take place until the police finished their investigations and the inquests. As my inquest had been granted Field Fisher Waterhouse were well aware of that as the reason why I would not put my evidence in the public domain at the GMC hearing. Why did my case go ahead at the GMC with a witness who was more concerned about herself and has been from the beginning in not divulging she committed perjury when registering the death, knowing the death certificate was false. If the GMC considers erasing Barton from the register is the end of the matter I am afraid you are mistaken. Please advise the name of the person I should write to at the GMC, forms to fill in etc. and whether I have any hope of seeing the papers submitted to you by the Police from 1999 onwards, Gillian M Mackenzie
