The Independent reports on the suicide of MS sufferer Cari Loder, who was also recognised for pioneering treatment for the disease. Ms Loder purchased a suicide kit over the internet as she feared being admitted into a care home as her condition deteriorated.

The first is a comment piece from Sarah Wotton, Chief Executive for Dignity in Dying, who makes it clear that she and her supporters wish for legal safeguards around the issue of assisted dying, not assisted suicide or euthanasia. The second is a blog from Royal College of GPs Chair Professor Code A who feels there is no place for assisted suicide in the UK. He argues for greater use of quality palliative care.
