A series of inquiries followed, including one by the GMC – Sir Peter stated that he hoped that he inquiries 'conclude quickly' but didn't mention any staff by name. 13 Sept 2004 – written questions on the ongoing inquiries – when they are expected to conclude and how many man hours have been expended by staff at Gosport Hospital 5 Feb 2007 – asked how many police man hours were involved in the inquiry at Gosport 23 March 2009 – written question asking when Professor Richard Baker's report in to events at Gosport would be published Sir Peter Viggers has recently (23 April 2009) been criticised by a number of relatives for refusing 'to help them in their fight for justice' and he also criticised the inquests into the deaths of 10 elderly patients earlier this year (hearings started Wednesday 18 March 2009), commenting that the police had decided no action was required and the issue should be 'allowed to rest'.
