We spoke some while ago regarding our stance concerning information we hold in relation to your investigation into the activities at Gosport War Memorial Hospital and our investigation into the actions of Dr Jane Barton.

We have now reviewed the records held by our legal advisors and have confirmed that the only pertinent information we hold are the medical records of the deceased patient in question.
