

Please find enclosed a list of all the documents that Hampshire Constabulary have amassed during the investigation into GWMH/Dr Barton. There are in fact a number of lists.

The first being a list of all documents that we have in our possession. This includes' other documents, messages, officers reports, statements, transmissions (E mails) and interviews.

Although this is a list of all the documents it only gives a cut down summary of the other documents and the name of the author for the officers reports and statements, I have therefore included further lists for the other documents giving a full summary and other lists for statements and officers reports also giving a summary of the content of the document but not the author, so the two lists will have to married together.

The action list outlines the task but doesn't give a result or indication as to whether the action was ever completed. The exhibits list is thankfully straight forward.
