## SUMMARY CONDITIONS OF CARRIAGE

#### CONDITIONS OF CARRIAGE

In these summary conditions, the terms below mean the following:-

- a) Us, we, our Interlink Express Parcels Limited.
- b) You, your the person, firm or company that enters into a contract of carriage or other services with us.

All carriage of goods is governed by our full standard terms and conditions of carriage, a copy of which is available on request.

#### LIABILITY

The full Conditions of Carriage set out the maximum we will pay to you for causing the physical loss of or physical damage to any goods while we are transporting them as defined in the full Conditions of Carriage providing that the goods do not fall into one of the classes excluded in clause 4 of the full Conditions of Carriage.

The maximum payment we will make is established at the time of the quotation when the required level of liability will have marked on the consignment note at one of the levels set out below.

We will not make any payment to you if the goods are lost or damaged due to poor packing or labelling or any event or circumstance beyond our control. A full list of exclusions is set out in clause 9 of the full Conditions of Carriage.

## STANDARD LIABILITY

For Standard Liability, on all services except Expresspak 1 and International, we will pay up to £12 per kg of gross weight lost or damaged but we will not pay more than £3,000 per Consignment.

#### INTERNATIONAL SERVICES

All carriage of goods will be governed by our full conditions of carriage and by the Convention on the Contract for the International Carriage of Goods by Road (CMR) and for goods carried by air up to £100 per Consignment unless the Warsaw Convention operates.

#### EXTENDED LIABILITY

For an additional charge which is recorded on the consignment note, the most we will pay, on all services, is £15,000 per Consignment. We work this out by referring to the actual value of the Consignment as set out in our published tariff.

If we have agreed in writing to provide "Extended Liability" at a rate by weight, the most we will pay is £15 a kilo or £10,000 a Consignment whichever is less.

## **CLAIMS**

Should you need to make a claim, please contact your local depot. If a Consignment is lost or damaged, you must tell us within 14 days of the date we collected the Consignment and you must confirm it in writing within 28 days of the date we collected the Consignment. If loss or damage is notified on a consignment note or electronic device you must still comply with this Condition.

## GOODS NOT ACCEPTED FOR CARRIAGE

We will accept most goods for carriage, but cannot carry anything classed as dangerous (firearms, poisonous or oxidising substances, radioactive material, corrosives etc.), anything which is hazardous or flammable nor will firearms, works of art, jewellery (including watches), cash, glass, documents which can be exchanged for cash or goods (for example cheques, vouchers with a face value), legal or business documents, precious metals (including gold or silver items), antiques, furs or any other valuables, alcohol, living or dead animals, fish or birds, body parts, human remains or any living organism of any type and frozen or perishable food be accepted. ## VOLUMETRIC GOODS

Our charges are based on weight, but should the volume of the goods exceed:-

- i) 6 cubic metres per tonne for goods consigned within mainland UK
- ii) 4 cubic metres per tonne for goods consigned outside mainland UK
- iii) 6 cubic metres per tonne for all Air Express services

we will charge by volume

### PROOF OF DELIVERY

The person receiving the goods must, if we ask, sign a document or electronic device as proof of delivery of the Consignment. Any computerised record of the receiver's signature that the electronic device has obtained will be evidence of the delivery of the quantity of Parcels within the Consignment.

## PAYMENT AND PRICING

If fuel, licence fees, labour or the other costs of running our business increase we may at any time increase our charges. However, we must give you at least 7 days written notice of any increase in our charges.
