Outcome..

Mr Paul Close (CPS) and one of the most senior barristers in the country have read and reviewed all the evidence. They have considered all of the elements of gross negligence manslaughter.

CPS has concluded in all of the remaining 10 cases that there is insufficient evidence to support a prosecution in respect of any case, for any criminal offence.

Nobody is stating that there weren't areas of concern-negligence in respect of the care of the individual patient. The purpose of the police investigation was to seek to establish whether there was any negligence of a criminal standard.

The legal position from the lawyers is that there is not sufficient evidence to meet that criminal standard. That being the case they have reached the conclusion that no criminal offence has been committed.

Where this is likely to go..

Even though no **criminal** offence appears to have been committed, that does not mean that the regulatory bodies for doctors and nurses would not wish to review what the same material. It may be that professional conduct issues are raised. Both the Nursing Midwifery Council & General Medical Council have asked for access to the case papers. Both of these bodies have had to wait until the end of the police investigation before making this request.
