Kevin,

Just to keep the boss in the picture regarding the latest messages received from Mrs McKenzie and her interaction with the Nursing & Midwifery Council.

Hampshire Constabulary have since 2002 worked closely with the NMC. Between 2005 & 2007 all 92 sets of medical notes relating to all the patients involved with Op Rochester were passed to regulatory bodies including the NMC. Since that time the NMC has been analysing what action, if any to take. They are currently progressing with certain matters.

No family member or NoK had to make a formal complaint or refer the notes as we did that on their behalf, and informed them in writing as we completed their case.

In the specific case of Mrs McKenzie. She had already made a complaint against specific nurses to the NMC which was investigated at the time (circa 2001). That complaint was not upheld. The NMC have decided that there is no further information to consider in her case and for that reason will not reopen the case.

I have confirmed this with Clare Strickland the lawyer from NMC this afternoon.

Clearly that is a matter for them. Our position is clear, we have passed everything that we had to them.

I do not intend to respond to Mrs McKenzie regarding this message as it appears to be not of our concern.
