I write to inform you of the outcome of the police investigation into the death of Violet Reeve.

This case in terms of potential negligence has been fully assessed by a panel of medical experts in Toxicology, Palliative Care, Geriatrics, General Medicine and Nursing and their assessment in terms of the quality of care delivered to patients prior to death has been further reviewed by a medical/legal lawyer who has independently agreed with the findings of the panel of experts. The concerns raised by family group members have been considered during this process.

This case is one of a number of category 2 cases which have been identified as instances where the treatment delivered to the patient was 'sub-optimal'. However this case has not been assessed as 'gross negligence to criminal standard' thereby justifying further criminal investigation. It follows that there is no basis upon which to continue a criminal investigation into this case.

The General Medical Council have expressed a wish to review the material in respect of this case enabling them to consider the issue of ongoing registration of relevant Healthcare Professionals. The Crown Prosecution Service views have been sought regarding disclosure of this information to the GMC, and subject to certain conditions the CPS have agreed that disclosure of material relating to this case will not prejudice the ongoing police investigation or subsequent criminal proceedings should they arise as a consequence of the investigation.

The Hampshire Constabulary and the GMC consider that there is a clear public interest in allowing the disclosure process to now take place.

It is not proposed to release the aforementioned information to the media given the potential to adversely affect the fairness of ongoing criminal proceedings. Please be mindful of this approach in the event of any personal media contact.

Please find attached a 'Consent to Supply information to the GMC document'. May I ask you to sign and return it to Hampshire police in the enclosed stamped addressed envelope as soon as possible, enabling the General Medical Counsel to commence their review of the relevant material.

Thank you for your patience and support throughout our investigation.
