Further...

As you might imagine there are a number of sensitivities around this investigation and the timing and order of release of the result are important..

Can I propose the following:-

1. Mr CLOSE comes to his decision and prepares the individual letters to families as previously discussed.
2. That the police take receipt of the letters and either post them or hand deliver them (as some of the families would prefer)
3. Will Paul be meeting with the families.. if so what will be the arrangements for that?..
4. Once the families have been notified the police will notify the 35 or so professional stakeholders of the decision..and arrange a meeting to discuss post decision issues..

I confirm no further material from us.. sorry.. thought I had previously mentioned that..

As you now have counsels advice could you please send us a copy..

Finally.. I think that it likely that some of the families may contact you direct to get advanced notification of the decision.. which would not be good and causes all sorts of tensions.. if giving individual results or indications generally are able to be avoided that would be good..
