I note your comments about Professor Baker's report and we will request disclosure from the office of The Chief Medical Officer as you suggest.

#### **Medical Records**

Do you know the whereabouts of the original medical records? We will need these for the hearing in due course and it would be helpful to have them as soon as possible in order that we make sure that the copies we have are complete and that we are working from as legible a set as possible. If you have them then I can request disclosure formally under separate cover if you require me to do so.

#### **Alice Wilkie**

Were any statements taken for this case? We have the medical records and it would appear that a police officer spoke to her daughter M. **Code A** after she had made a complaint. However we do not have any statements. We would be grateful if you could confirm if there are any statements and provide us with copies if there are.

**Jean Stevens** **Code C**

We do not have any information, other than medical records, with regard to these patients. I have spoken to Mrs Stevens son and he has informed me that interviews were carried out by the Police. We do not, however, have copies of any statements or transcripts of interviews. Please could you advise what information you do have in relation to these patients and then provide us with copies.
