Operation ROCHESTER financial returns.. For consideration by ACCSO WATTS.. For any observations he would wish to add to the response to Mr VIGGERS..

The caveat that needs to be applied within the letter to Mr VIGGERS is that in terms of the police officer and staff costs, these are estimated... at 50% of the officer time seconded to OP ROCHESTER. All officers performed other roles tasks and investigations during their deployment

..

Operation ROCHESTER in its current iteration investigated 92 reports of suspicious death at Gosport War Memorial Hospital the investigation taking place between Sept 2002 and December 2006. H.M.CORONER is considering the matter of inquests in respect of ten of those cases.

All available medical records were seized and examined by an array of medical experts 119 family members of deceased were kept updated throughout..

Ten full case files comprising 368 witness statements (about half of the number taken by the enquiry team) were considered by the CPS who determined that the evidence had not satisfied the prosecution test in terms of sufficiency of evidence and public interest and therefore there was no criminal prosecution of healthcare staff.

Costs:-

£642,000 - Police and Police staff basic salary (15 staff variously deployed)

£633,000 - Other costs incorporating - £61,000 transport costs
£298,000 expert witness fees.
£18,000 hotels and conference facilities
£ 24,000 I/T costs.
£ 78,000 legal services.
£ 6,000 subsistence.
£61,000 police overtime.

Total cost :- £1.275 million.. Averaging out across 92 investigations at £13,860 per investigation...

I have made some calculations around the amount of officer time spent on each case.. On average 5.4 days per officer for each of the 92 cases investigated..
