

### Operation Rochester

#### Dear Dr WILCOCK

Finally you review statements obtained from other healthcare professionals involved in that patients care together with any family member statements with a view to revising or maintaining your position in the light of all relevant information.

I appreciate that this has been a lengthy process of deliberation with a significant amount of material requiring review in each and every case. I am grateful for your ongoing response mindful that it is additional to the significant day to day workload that you must be carrying.

To date you have completed the following.

A review of the patient records in respect of DEVINE LAVENDER & Code C

A review of the statement of Dr BARTON in respect of the three aforementioned patients.

A review of the statements of other healthcare professionals in respect of these cases.

To date we have been invoiced £46,295 in respect of the work to date against a mutually agreed 'hourly rate' contract (an average of approximately £15,000 per case).

There is no doubting the depth and quality of your work, however as a custodian of the public purse I am bound to highlight that should your analysis in respect of the remaining nine cases follow a similar pattern in terms of timescales and cost it will take at best 2 years to complete at a cost of £150,000.

By any standards the projected cost at current rates is high. I would ask that you consider a negotiated fixed fee for completion of work in respect of this case.

I would also like to discuss the timetable for projected work during 2005. At present we have submitted three sets of case papers to the Crown Prosecution Service in London for their consideration. These relate to DEVINE LAVENDER & Code C

We have timetabled police interviews with Dr Jane BARTON to take place during the last week of each month throughout 2005.

Dr BARTON is interviewed and provides a written statement of her views in relation to a particular case. On conclusion of that interview she is given another set of records to review and invited back a month later. To that end it is essential that we try and have an expert review of the papers completed at the same time.

May I ask that you review a set of records in respect of the outstanding 9 cases on a monthly basis?

It would be evidentially beneficial to the investigation to approach each of the interviews with the benefit of expert opinion. I am able to supply a complete set of these records as soon as you are able to receive them.

May I again thank you for you significant work around this case.
