I have spoken to becran code containment. (UK CENTRAL AUTHORITY) There is no formal treaty with Vietnam, but he has checked and they have dealt with MLA requests in the past. He has confirmed that they can provide reciprocity assurances with any request that goes out. Therefore, Hampshire have 3 choices:
