I have passed on your best wishes to Nivel NIVEN, they were much appreciated.

I am likely to be travelling to London on the 10th or 11th June 2004 to meet with the CMO and to discuss a number of issues including the concerns raised regarding Jane BARTONS ongoing status.

Would either of these dates be suitable to yourself for a meeting?.. About 1100am?..

You have raised the issue of counselling for family members. Having spoken with our Family Liaison Officer I am aware that whilst some of the group members have been referred to their individual GP's none have specifically asked for counselling through the police FLO. Whilst I appreciate the potential trauma to family members no specific instance has been raised to date. We will seek to refer such instances to the individuals own GP who must be in the best position to make an immediate assessment towards a requirement for counselling.

I am seeking to appoint a police family liaison coordinator as this investigation enters a new phase to review and manage family liaison issues. My personal focus will remain towards the investigation of allegations. I am hoping that when Nigel NIVEN returns he will take on the continuing liaison role with yourself and other stakeholders.

In response to your request for individual family members to be debriefed personally by a suitably medically trained person, in essence this is being done through the ongoing written feedback provided by Mathew LOHN. I would not seek to extend this to personal briefings which are likely

to be considerably time consuming and detract from the focus of our investigation.

I look forward to meeting with you, hopefully in June.
