Julia, I had a phone call from Mrs. MacKenzie yesterday regarding the complaint against John James re Gosport War Memorial Hospital.

## She stated that:

Mr. Jacobs looked into an investigation regarding Ch. Supt. John James. She had received information abut the CPS, etc., from Ch. Supt. James with the excuse that he had not been able to write because he had been involved in a murder. He went on to see her sister and followed up with a letter of apology and she feels the circumstances of the meeting should be looked at. It did not take place in her sister's house, and only came about because her sister's daughter (Pita Holt) mentioned it to John James. Her sister met with John James elsewhere and received an abject letter of apology. John James has put himself in a very compromising position and one would not expect that of a senior police officer. She was in personnel management herself. She thinks Mr. Jacobs should have a look at that - the difference between the two letters and the fact that she received a letter and her sister had a meeting with him.

I have not sent this message to **Code A** (who have asked to be kept informed of any contact with relatives so that they can update the spreadsheet on Operation Rochester) as this relates solely to the complaint against John James. Please can you inform them if necessary.

Welcome to the enquiry, I look forward to meeting you at some time.

Hopeful Claire or Ann Alexander will have briefed you on the situation regarding Gillian MacKenzie. Almost daily she rings the incident room, Peter Rushworth or the PA to Steve Watts wishing to complain or discuss various issues.

There is a meeting this weekend between the Police and a team of medical experts and Peter will be attending. At the family group meeting in February the families were informed or our intention to obtain expert opinion from a team of medical experts and that the team would be provided with the medical records of 62 persons.

Mrs Mackenzie can be informed that the meeting with the medical team is taking place and that it is part of the ongoing Police enquiry. We have given an undertaking to maintain regular contact with the families and to update them on the progress of the investigation as and when necessary. It is not necessary to update the families with any aspect of the enquiry at present. We do not yet know how long it will take for the experts to analyse the patient records and report their findings but as soon as we have some idea we will inform the families.

I hope the above is of some assistance.
