CHI INVESTIGATION AT GOSPORT WAR MEMORIAL HOSPITAL

The Commission for Health Improvement (CHI) has launched an investigation at Gosport War Memorial Hospital, following reported concerns about the quality of care for older people provided by the hospital and the culture in which it is delivered.

The investigation follows concerns expressed by the public about the administration of drugs at the hospital around 1998 and general concerns about standards which attracted coverage in the local media. The investigatio will particularly look at whether, since 1998, trust systems have ensured good quality patient care and prevented harm to patients, looking in detail at:

- arrangements for administering drugs
- clarity of responsibility for patient care
- transfer arrangements for patients between Gosport War Memorial Hospital and other local hospitals

CHI will conduct the investigation with the cooperation of the organisations involved, including Portsmouth Healthcare NHS Trust, of which Gosport War Memorial Hospital is part, and its partner organisations.

CHI will begin the investigation by collecting relevant information and analysis it. Local organisations and members of the public will be invited to give their experience of care for older people at the hospital and these opportunities wil be publicised locally. The investigation team will visit the hospital for a week and carry out interviews and visit clinical areas. A report, which will be available to the public, will be published next year.

General hospital services in Portsmouth are provided by a separate organisation, Portsmouth Hospitals NHS Trust, which is currently being reviewed by CHI as part of its rolling programme of routine assessments of every NHS organisation in England and Wales. Their review is not connected with this investigation.

CHI Chief Executive, Peter Homa, said "CHI is undertaking this investigation t look into concerns over the quality and culture of care that the patients, who are elderly and particularly vulnerable, have received at Gosport War Memoria Hospital. The trust which runs the hospital is keen to work closely with us to address these concerns and work to improve the quality of care provided. The findings of our investigation will result in lessons for the whole of the NHS, an this is especially important at a time when community and primary care services are undergoing major change."

Notes to Editors

- CHI is an independent body set up to help the NHS monitor and improve clinical care across England and Wales.
- Terms of reference for the investigation are attached
- CHI investigates serious service failures in the NHS when requested by the Secretary of State for Health in England and the National Assembly for Wales and will carefully consider other requests. CHI also undertake a rolling programme of clinical governance reviews in every NHS trust, health authority, primary care group or trust and local health group across England and Wales.
- Further details of the investigation and how local people can participate in the investigation, will be circulated in the next few weeks.

General

- The Commission's management structure comprises a Board with 13 commissioners and chairman, Dame Deirdre Hine.
- CHI does not cover Scotland as it has its own body, the Clinical Standards Board for Scotland. The First Minister for Northern Ireland ma invite CHI to undertake work at some point in the future.
- CHI's role is to undertake regular clinical governance reviews as well as hold investigations or inquiries into serious service failures. It is also responsible for studies which monitor and review the implementation of National Service Frameworks and National Institute for Clinical Excellent (NICE) guidance.
