**1. Citation and commencement**

This Order may be cited as the National Health Service (Determination of Districts) Order 1981 and shall come into operation on 1st April 1982:

**2.— Interpretation**

(1) In this Order, unless the context otherwise requires—

*"the Act"* means the National Health Service Act 1977;*"the Constitution Order"* means the National Health Service (Constitution of District Health Authorities) Order 1981;*"the material date"* means 1st April 1982;*"new authority"* means a District Health Authority established by virtue of article 3(1) of the Constitution Order;*"old authority"* means an Area Health Authority the name of which is set out in Parts I and II of Schedule 1 to the Constitution Order;*"Regional Authority"* means a Regional Health Authority;*"region"* means the region known by that name by virtue of the National Health Service (Determination of Regions) Order 1981.(2) Any reference in this Order to the holder of an office is a reference to the person who from time to time is the holder of that office, and the expressions "*charity*", "*charity trustees*" and "*trusts*" have the same meaning as in the Charities Act 1960.

(3) In Schedules 1 and 2 to this Order—

(a) references to existing local government areas are references to such areas as existing on 1st August 1981 and paragraph (1)(b) of regulation 40 (statutory definitions of areas) of the Local Government Area Changes Regulations 1976 shall not apply in relation to such areas;

(b) references to the areas of former boroughs and former urban and rural districts are references to such areas as existing immediately before 1st April 1974;

(c) references to wards are to wards the boundaries of which are fixed by the Orders specified in those Schedules as at the date upon which each of the relevant Orders comes into operation and, if such an Order has not come into operation at the date of the coming into operation of this Order, as if that Order had come into operation on 1st April 1982.

### 3.— Determination of Districts

(1) Each of the districts in England described in column (3) of Part I of Schedule 1 to this Order shall be a district for which a District Health Authority shall be established and each such district shall be known by the name set opposite thereto in column (2) of that Part of that Schedule.

(2) Each of the districts in England described in column (3) of Part II of Schedule 1 to this Order, being a district which corresponds with the area of an existing Area Health Authority the name of which area is set opposite thereto in column (4) of that Part of that Schedule, shall be a district for which the existing Area Health Authority shall be constituted a District Health Authority and each such district shall be known by the name set opposite thereto in column (2) of that Part of that Schedule.

(3) The region within which each district in England is included is that one of the regions set out in the Schedule to the National Health Service (Determination of Regions) Order 1981, and numbered 1 to 14 in that Schedule, of which the corresponding number is set out in column (1) of Parts I and II of Schedule 1 to this Order opposite the name of the district in column (2) thereof.

(4) Each of the districts in Wales described in column (2) of Part I of Schedule 2 to this Order shall be a district for which a District Health Authority shall be established and each such district shall be known by the name set opposite thereto in column (1) of that Part of that Schedule.

(5) Each of the districts in Wales described in column (2) of Part II of Schedule 2 to this Order, being a district which corresponds with the area of an existing Area Health Authority the name of which area is set opposite thereto in column (3) of that Part of that Schedule, shall be a district for which the existing Area Health Authority shall be constituted a District Health Authority and each such district shall be known by the name set opposite thereto in column (1) of that Part of that Schedule.

### 4. Transfer of officers

Any officer of an old authority specified in column (1) of Part I or Part II of Schedule 3 to this Order designated by a scheme made by that authority for the transfer on the material date of persons

employed by that authority to the employment of such new authorities specified in column (2) of the appropriate Part of that Schedule opposite the name of that old authority as may be designated in such scheme shall on the material date be transferred to the new authority so designated and the contract of employment between such officer and the old authority by which he was employed shall be modified so as to substitute as the employer the new authority to which he is transferred.



#### 5. Preservation of training arrangements

Where arrangements have been made by an old authority under which any officer transferred by or under this Order is undergoing, or is to undergo, a course of training or has entered, or is going to enter, into an apprenticeship and those arrangements have not been discharged before the material date, those arrangements shall continue to apply with the substitution for the old authority by which he was employed immediately before the material date of the new authority to which he is transferred by or under this Order.



#### 6.— Transfer of trust property of old authorities

(1) The trust property vested immediately before the material date in an old authority specified in column (1) of Part I or Part II of Schedule 3 to this Order shall on the material date be transferred to and vest in the new authorities specified in column (2) of the appropriate Part of that Schedule opposite the name of that old authority in such proportions as those new authorities may agree or in default of agreement in such proportions as may be determined by the Secretary of State.

(2) Paragraph (1) of this Article shall not apply in relation to trust property vested in an old authority specified as mentioned in that paragraph which is transferred to special trustees appointed under section 95 of the Act or to a special health authority by virtue of an Order made under section 92 of the Act which comes into operation on the material date.

#### 7.— Appointment of new trustees

(1) Where under the trusts of any charity connected with health service purposes (not being a charity incorporated under the Companies Acts 1948 to 1980 or by Royal Charter) modified by the provisions of the National Health Service (Amendment of Trust Instruments) Order 1974 (in this Part of this Order called "*the 1974 Order*") so far as those provisions apply to the trusts—

(a) the charity trustees immediately before the material date include the holder of an office connected with an old authority, those trustees shall instead include by virtue of this Order the holder of such office as may be designated—

(i) where the service with the purpose of which the charity is connected and which is provided in whole or in part by the old authority will be provided by more than one new authority after the material date, by those new authorities either jointly or severally, as they may agree;

(ii) where the hospital with the purposes of which the charity is connected is a hospital for which special trustees have been appointed under section 29 of the National Health Service Reorganisation Act 1973 or section 95 of the Act, by the new authority which will administer the hospital with the purposes of which the charity is connected on the nomination of those special trustees;

(iii) in any other case, by the new authority which will administer the hospital or provide the service with the purposes of which the charity is connected;

(b) the charity trustees immediately before the material date include the holder of an office connected with an existing Area Health Authority which is constituted a District Health Authority by paragraph (2) or paragraph (3) of Article 3 of the Constitution Order (in this Part of this Order called "*a continuing authority*") which by virtue of Article 2 of the 1974 Order is designated by an old authority and a continuing authority jointly, those trustees shall instead include by virtue of this Order the holder of such office as may be designated—

(i) where the service with the purpose of which the charity is connected and which is provided in whole or in part by the continuing authority will be provided by the continuing authority and a new health authority after the material date, by the continuing authority and the new health authority either jointly or severally, as they may agree;

(ii) where the hospital with the purposes of which the charity is connected is a hospital for which special trustees have been appointed under section 29 of the National Health Service Reorganisation Act 1973 or section 95 of the Act, by the authority which will administer the hospital with the purposes of which the charity is connected on the nomination of the special trustees;

(iii) in any other case, by the continuing authority or the new authority which will administer the hospital or provide the service with the purposes of which the charity is connected.

(2) Where, immediately before the material date, by virtue of Article 2 of the 1974 Order a charity trustee is the holder of an office designated by an old authority or authorities and a continuing authority jointly, paragraph (1)(a) of this Article shall apply as if the reference to a new authority included a reference to a continuing authority.

#### 8. Vesting of trust property

Where, immediately before the material date, any property belonging to a charity connected with health service purposes is held solely by a trustee or trustees, being the holder or holders of an office to which Article 7 of this Order applies, that property shall by virtue of this Order vest (on the same trusts) on the material date or on the date of designation, whichever is the later, in the holder or holders of the office or offices designated under the provisions of that Article.

## 9.— Exercise of powers

(1) Where, immediately before the material date, any power (including a power to appoint trustees but not including any power by virtue of being a charity trustee thereof) with respect to a charity connected with health service purposes (not being a charity incorporated under the Companies Acts 1948 to 1980 or by Royal Charter) is under the trusts of the charity, modified by the provisions of the 1974 Order so far as those provisions apply to the trusts vested in, or in the holder of an office connected with, an old authority or old authorities, subject to paragraph (2) of this Article, that power shall—

(a) where the power relates to a hospital which will be administered, or a service which will be provided, by one new authority, vest on the material date in that authority or, as the case may be, in the holder of an office connected with and designated by that authority;

(b) where the power relates to a service which will be provided by two or more new authorities, vest on the material date in those authorities either jointly or severally as they may agree or, as the case may be, in the holder of an office connected with one or those authorities designated jointly or severally as they may agree by those authorities.

(2) Where, immediately before the material date, any such power as is mentioned in paragraph (1) of this Article is under the trusts of the charity—

(a) vested in a continuing authority, that power shall continue to be exercisable by that authority;

(b) vested in the holder of an office connected with a continuing authority, that power shall on the material date vest in the holder of an office connected with and designated by that authority.

(3) Where, immediately before the material date, by virtue of Article 4 of the 1974 Order, a power is vested in the holder of an office connected with an old authority designated by an old authority or authorities and a continuing authority jointly, paragraph (1)(b) of this Article shall apply as if the reference to new authorities included a reference to a continuing authority.

(4) Where the charity to which such a power as is mentioned in paragraph (1) or paragraph (2) of this Article relates is wholly or mainly associated with a hospital or hospitals for which special trustees have been appointed under section 29 of the National Health Service Reorganisation Act 1973 or section 95 of the Act, a designation under paragraph (1), (2) or (3) of this Article shall be made by the authority or authorities concerned on the nomination of the special trustees.

(5) Where a designation of an officer is made on a date which is after the material date the vesting in that designated officer of the power referred to in paragraph (1), (2) or (3) of this Article shall take effect on that later date.

**11. Choice of trustees**

In making designations under this Part of this Order a new authority, and in making nominations under this Part of this Order special trustees, shall secure that so far as is practicable the offices of the new trustees designated under this Part of this Order or the offices of persons to whom powers are transferred by this Order, shall correspond as closely as possible to the offices of the trustees, or of those persons, as they exist immediately before the material date.



**12.— Enforceability of rights and liabilities**



(1) Subject to the following provisions of this Order, any right or liability which was enforceable by or against an old authority shall be enforceable by or against the new authority exercising, in place of such old authority, the function in respect of which such right or liability was acquired or incurred.

(2) Any right or liability which was enforceable by or against an old authority in respect of the employment by such authority of any officer who is transferred to the employment of a new authority by virtue of Article 4 of this Order shall be enforceable by or against such new authority.

(3) Any right or liability which was enforceable by or against an old authority in respect of any property shall be enforceable by or against the new authority which, by virtue of directions given under sections 13 and 14 of the Act, controls and manages such property on the material date.

(4) Any right of an old authority to secure payment of a debt due to that authority or under an undertaking to pay any charges, incurred before the material date, for accommodation or services, and any liability on the part of such an authority for payment of a debt, shall be enforceable by or against the new authority directed, in accordance with Article 13 of this Order, to wind up the affairs of that old authority.

(5) Any right or liability which was enforceable by or against an old authority constituted for an area in England or Wales and which, by virtue of any of the foregoing provisions of this Article is not enforceable by or against any new authority or is enforceable by or against more than one new authority shall be enforceable in respect of an authority constituted for an area in England by or against the Regional Authority within whose region the district of the new authority is included or, in respect of an authority constituted for an area in Wales by or against the Welsh Health Technical Services Organisation <sup>1</sup>

## 13. Winding up affairs of old authorities

It shall be the duty of any health authority so directed by the Secretary of State or, where the health authority is constituted for a district in England, so directed by the Regional Authority within whose region the district of that authority is included, to take, in accordance with any such directions as aforesaid, such action as may be necessary for the winding up of any of the affairs of an old authority.

**14. Accounts of old authorities**

Where, on the material date, an old authority has not performed in respect of any period before the material date any duty imposed upon that authority by section 98 of the Act it shall be the duty of any health authority so directed by the Secretary of State or, where the health authority is constituted for a district in England, so directed by the Regional Authority within whose region the district of that authority is included, to perform such duty in accordance with the provisions of that section, any regulations made under that section and any directions that may be given by the Secretary of State.



**15.— Provision for continuity in exercise of functions**

(1) Anything duly done by, and any application duly made, or any direction, authorisation or notice duly given to, an old authority in connection with the exercise, by an old authority, of any function which, by virtue of directions given under sections 13 and 14 of the Act or of any other provision of the Act, is a function exercisable by a new authority, shall be deemed to have been duly done by, or made or given to, the new authority exercising such function on the material date in place of the old authority by which such thing was done or to which such application was made or such direction, authorisation or notice was given.

(2) Any instrument made by an old authority, in so far as it was made in the exercise of any function referred to in paragraph (1) above, shall continue in force until it is varied or revoked by

the new authority exercising such function in place of the old authority by which such instrument was made.

(3) Any form supplied by an old authority in exercise of a function which, by virtue of any directions given under sections 13 and 14 of the Act or of any other provision of that Act, is a function exercisable by a new authority and any form supplied by the Secretary of State shall continue to be a valid form in connection with the exercise of any function until it is cancelled or withdrawn by the Secretary of State or by the new authority exercising the function in place of the old authority by which the form was supplied, as if any reference contained in such a form to the old authority by which the function was exercisable before the material date were a reference to the new authority exercising that function on that day.

**16. Modifications relating to joint user arrangements under the National Assistance Act 1948**

Paragraphs 6, 7 and 8 of Schedule 6 to the National Assistance Act 1948 <sup>1</sup>, and any arrangements, agreements or determinations made under any of those paragraphs, shall have effect as if any reference to an Area Health Authority included a reference to a District Health Authority and as if for sub-paragraph (5) of the said paragraph 7 there were substituted the following sub-paragraph:—

“(5) any expenditure of an Area or District Health Authority under head (b) of sub-paragraph (1) of this paragraph shall be deemed for the purposes of section 97(1) <sup>2</sup> of the National Health Service Act 1977 to be expenditure of such an authority approved by the Secretary of State as mentioned in that section.”.

**17.— Accommodation and services made available on payment of charges**

(1) To the extent that any accommodation and services at any hospital is, immediately before the material date, authorised by the Secretary of State to be made available under section 65(1) or section 66(1) of the Act <sup>1</sup> it shall be deemed to be authorised to be made available under the appropriate section, to the extent determined, on or after that date until such authorisation is varied or revoked by the Secretary of State.

(2) Without prejudice to the generality of the provision made by Article 15 of this Order—

(a) any authorisation given by a health authority under section 63 of the Act for making available any hospital accommodation on payment of charges for part of the cost;

(b) the allowing by a health authority under section 65(2) of the Act of accommodation and services to be made available in connection with the treatment, in pursuance of arrangements made by medical and dental practitioners, of their private patients as resident patients;


(c) any determination by a health authority under section 66(1) and (2) of the Act of charges for non-resident patients where no relevant determination has been made by the Secretary of State;

in exercise of functions under the National Health Service Functions (Directions to Authorities) Regulations 1974 of the National Health Service Functions (Directions to Authorities) Regulations 1980 in respect of any hospital shall continue in force until varied or revoked in accordance with the provisions of the Act.

## 18.— Family Practitioner Committees

(1) Subject to the following provisions of this Article, any right or liability which was acquired or incurred by an old Committee—

(a) in respect of or in consequence of an application for inclusion in an old Committee's list of persons undertaking to provide general medical services, general dental services, general ophthalmic services or pharmaceutical services or in respect of or in consequence of inclusion in any such list:

(b) in respect of or in consequence of any arrangements made by an old Committee for the supply of drugs and appliances by a medical practitioner; or

(c) by virtue of any regulations made under the Act relating to the making and recovery of charges for drugs and appliances;

shall be enforceable—

(i) in a case, other than a case to which paragraph (6) of this Article applies, connected with the provision of general medical services or the supply of drugs and appliances by a medical practitioner under the National Health Service (General Medical and Pharmaceutical Services) Regulations 1974 by or against the Committee established for the district in which there resides, on 1st April 1982, the largest proportion of the total number of persons the medical practitioner concerned has on his lists in all districts in which he provides general medical services; and

(ii) in a case connected with the provision of general dental services, general ophthalmic services or pharmaceutical services (except the supply of drugs and appliances by a medical practitioner referred to in sub-paragraph (i) above) by or against the Committee established for the district in which are situated the practice premises, relevant to the case, of the person undertaking to provide such services.

(2) Any right or liability which was acquired or incurred by an old Committee to which paragraph (1) of this Article relates and which, by virtue of that paragraph is not made enforceable by or against any Committee or is made enforceable by or against more than one Committee, shall be enforceable by or against the Committee established for the district which includes all or the largest part of the area of the old authority by which the old Committee was established.

(3) All arrangements for the provision of general medical services, general dental services, general ophthalmic services and pharmaceutical services made by an old Committee shall, so far as they relate to the district of a new authority, remain in full force and effect as if made by the Committee established by that new authority.

(4) Any decision given by an old Committee or a Local Medical Committee, Local Dental Committee, Local Optical Committee or Local Pharmaceutical Committee formed for the area of an old authority shall, insofar as it relates to the district of a new authority, have effect as if it had been given by the Committee established by the new authority or the Local Medical Committee, Local Dental Committee, Local Optical Committee or Local Pharmaceutical Committee, as the case may be, formed for the district of the new authority.

(5) Any reference in any instrument to a Local Medical Committee, Local Dental Committee, Local Optical Committee or Local Pharmaceutical Committee formed for the area of an old authority shall,

insofar as it relates to the district of a new authority, have effect as if it were a reference to the corresponding Committee for the district of a new authority.

(6)

(a) Any proceedings under Part II of the National Health Service (Service Committees and Tribunal) Regulations 1974<sup>1</sup> in relation to services provided before the material date in the area of an old authority may be instituted or, as the case may require where proceedings have already been instituted before that date, shall be continued by the Committee established for the district of a new authority in which are situated the practice premises, relevant to the case, of the person undertaking to provide such services:

Provided that any direction for the withholding of remuneration following such proceedings may be given to such Committee as the Secretary of State may think fit.

(b) Any representations made under Part III of the National Health Service (Service Committees and Tribunal) Regulations 1974 by an old authority or a Committee established by that authority shall be continued in a case to which paragraph (1)(i) of this Article refers by the Committee therein prescribed and in a case to which paragraph (1)(ii) of this Article refers by the Committee therein prescribed.

(7) Any proceedings instituted before an old Committee for determining whether the replacement or repair of any dental or optical appliance is necessitated by an act or omission of the person supplied or (if the act or omission occurred when the person supplied was under 16 years of age) of the person supplied or of the person having charge of him when the act or omission occurred shall where the practice premises referred to in the application for the replacement or repair of the appliance are situated in the area of the old authority by which the old Committee was established be continued with the substitution for the old Committee of the Committee established for the district of the new authority in which the practice premises are situated.

(8) Any medical practitioner whose name is included on the medical list of an old Committee immediately before the material date shall be entitled to be placed on the medical list of any Committee established for the district of a new authority if on the material date—

(a) he has practice premises in such district, or

(b) any patient on his list resides permanently in such district:

Provided that nothing in this Article shall entitle a medical practitioner to provide services in any part of any district unless he was entitled to provide services in that part immediately before the material date.

(9) Any practitioner who has undertaken to provide general dental services, general ophthalmic services or pharmaceutical services under section 35, 38 or 41 of the Act whose name is included in the appropriate list of practitioners prepared by an old Committee shall be entitled to be placed on the appropriate list of any Committee established for the district of a new authority in which his practice premises are situated.

(10) Anything duly done by, and any application duly made, or direction, authorisation, or notice duly given to—

(a) the Secretary of State;

(b) an old Committee;

(c) the Prescription Pricing Authority<sup>2</sup>;

(d) the Dental Estimates Board; or

(e) any other body,

shall, insofar as it relates to the area of an old authority for which an old Committee was established, be deemed to have been duly done by or made or given to the Committee exercising such function in place of the old Committee.

(11) Any instrument made by an old Committee, insofar as it was made in the exercise of any function which is exercisable by a Committee shall continue in force until it is varied or revoked by the Committee exercising such function in place of the old Committee by which such instrument was made.

(12) Any form supplied by an old Committee in the exercise of a function which is a function exercisable by a new Committee and any form supplied by the Secretary of State shall continue to be a valid form in connection with the exercise of any function until it is cancelled or withdrawn by the Secretary of State or by the Committee exercising the function in place of the Committee by which the form was supplied as if any reference contained in such a form to a Committee were a reference to the Committee exercising that function on the material date.

(13) In this Article—

(a) "*Committee*" means a Family Practitioner Committee and "*Old Committee*" means a Committee established by an old authority which has not been adopted by two or more new authorities in accordance with a direction by the Secretary of State under section 2(2) of the Health Services Act 1980;

(b) references to the district of a new authority shall, where the context admits, include references to the combined districts of two or more new authorities which have been directed by the Secretary of State under subsection (1) or (2) of section 2 of the Health Services Act 1980 to establish a Committee for their combined districts or to adopt an existing Committee;

(c) references to a Committee established by a new authority shall, where the context admits, include references to a Committee established or adopted by two or more new authorities pursuant to a direction by the Secretary of State under subsection (1) or (2) of section 2 of the Health Services Act 1980.

### 19.— Investigation of complaints by the Health Service Commissioners

(1) A complaint made under Part V of the Act to the Health Service Commissioner for England in relation to an old authority constituted for an area in England and such a complaint made to the Health Service Commissioner for Wales in relation to an old authority constituted for an area in Wales, whether made before or after the material date, may be investigated by the appropriate Commissioner notwithstanding the abolition of the authority as if the complaint had been made in relation to the new authority exercising in place of that old authority the function in respect of which the complaint was made.

(2) The Health Service Commissioner for England, where he conducts an investigation, shall send a report of the results of his investigation to the new authority and to the Regional Authority within whose region the district of the new authority is situated and the Health Service Commissioner for Wales, where he conducts an investigation, shall send such a report to the new authority and to the Secretary of State.

### 20. Appointment to act on behalf of persons unable to act for themselves

Any appointment made by the Secretary of State for the purposes of the Family Income Supplements Act 1970, the Social Security Act 1975, the Industrial Injuries and Diseases (Old Cases) Act 1975, the Child Benefit Act 1975 or the Supplementary Benefits Act 1976, of an old authority or of a person holding a specified office with an old authority to exercise, on behalf of a person unable to act by reason of mental or other incapacity, any right which such person may have under any of those Acts, shall continue to be a valid appointment as if any reference therein to the old authority or person holding the said office were a reference to the District Health Authority which, by virtue of directions given under sections 13 and 14 of the Act, controls and manages, on the material date, the hospital at which the person, on whose behalf the appointment to act has been made, is receiving treatment.



This Order determines districts in England and in Wales for which District Health Authorities are to be established under the National Health Service Act 1977. The Order contains provisions for the transfer of staff employed by Area Health Authorities which will cease to exist to District Health Authorities, and provisions for the transfer of trust property held by those Area Health Authorities, and the transfer of other property, rights and liabilities from those Authorities to District Health Authorities. The Order also makes provision for complaints made to the Health Service Commissioner for England or the Health Service Commissioner for Wales in respect of Area Health Authorities which will cease to exist to be investigated.
