**1.— Citation, commencement and interpretation**

(1) This Order may be cited as the Portsmouth Health Care National Health Service Trust (Transfer of Trust Property) Order 1995 and shall come into force on 26th April 1995.

(2) In this Order—

*"the Authority"* means the Portsmouth and South East Hampshire Health Authority;

*"the Trust"* means the Portsmouth Health Care National Health Service Trust;

"the trust property" means the items specified in a schedule of trust property prepared by and agreed upon by the Authority and the Trust on 2nd November 1994, which schedule has been signed on behalf of both the Authority and the Trust.
