# THE EAST HAMPSHIRE PRIMARY CARE TRUST (TRANSFER OF STAFF, PROPERTY, RIGHTS AND LIABILITIES) ORDER 2006

The Secretary of State for Health makes this Order in exercise of the powers conferred by section 126(4) of, and paragraphs 20 and 26 of Schedule 5A to, the National Health Service Act 1977(a). She is satisfied that consultation has taken place in accordance with regulations made under section 16A(5) of that Act(b).

#### Citation, commencement and interpretation

1.—(1) This Order may be cited as the East Hampshire Primary Care Trust (Transfer of Staff, Property, Rights and Liabilities) Order 2006 and shall come into force on 1st October 2006.

(2) In this Order-

"the Establishment and Dissolution Order" means the Primary Care Trusts (Establishment and Dissolution) (England) Order 2006(c);

"the new PCT" means the Hampshire Primary Care Trust which is established by the Establishment and Dissolution Order;

"the old PCT" means the East Hampshire Primary Care Trust which is dissolved by the Establishment and Dissolution Order;

"the Portsmouth City Teaching PCT" means the Portsmouth City Teaching Primary Care Trust which was established by the Portsmouth City Primary Care Trust (Establishment) Order 2001(d);

"the Portsmouth Hospitals NHS Trust" means the Portsmouth Hospitals National Health Service Trust which was established by the Portsmouth Hospitals National Health Service Trust (Establishment) Order 1992(e); and

"the Portsmouth Hospitals NHS Trust Transfer Schedule" means the document produced by the old PCT and entitled "Portsmouth Hospitals NHS Trust Transfer Schedule - Schedule of Liabilities Transferring from the East Hampshire Primary Care Trust to the Portsmouth Hospitals National Health Service Trust" and dated 25th September 2006.

### Transfer of staff to the new PCT

- 2.—(1) This article applies in relation to any person who—
  - (a) was an employee of the old PCT immediately before 1st October 2006; and

(b) is not identified in article 3(1) or 4(1).

- (2) Any person to whom this article applies shall on 1st October 2006 be transferred to the employment of the new PCT.
  - (3) The contract of employment of an employee transferred under paragraph (2)—
    - (a) is not terminated by the transfer; and
    - (b) shall have effect on and after 1st October 2006 as if originally made between that employee and the new PCT.
  - (4) Without prejudice to paragraph (3)—
  - (a) all the rights, powers, duties and liabilities of the old PCT under, or in connection with, a contract to which that paragraph applies shall, by virtue of this article, be transferred to the new PCT on 1st October 2006;
  - (b) anything done before that date by or in relation to the old PCT in respect of that contract or that employee shall be deemed on and after 1st October 2006 to have been done by or in relation to the new PCT.
- (5) Paragraphs (2) and (3) are without prejudice to any right of any employee to terminate his contract of employment if a substantial and detrimental change is made to that employee's working conditions, but no such right shall arise by reason only of the change of employer effected by this article.
- (6) Paragraphs (2) and (3) do not transfer an employee's contract of employment, or the rights, powers, duties and liabilities under or in connection with it, if that employee has objected to the transfer to the new PCT and had informed the old PCT of that objection on or before 30th September 2006.
- (7) Where an employee has informed the old PCT of his objection as mentioned in paragraph (6), his contract of employment with the old PCT shall be terminated immediately before the date on which the transfer would occur, but he shall not be treated, for any purpose, as having been dismissed from the old PCT.

## Transfer of staff to the Portsmouth City Teaching PCT

- 3.—(1) This article applies in relation to any person who—
  - (a) was an employee of the old PCT immediately before 1st October 2006;
  - (b) was employed immediately before 1st October 2006 to work at Jubilee House, Medina Road, Cosham, Portsmouth, PO6 3NH; and
  - (c) has been notified in a letter posted on or before 1st September 2006 that he is to be transferred to the employment of the Portsmouth City Teaching PCT.
- (2) Any person to whom this article applies shall on 1st October 2006 be transferred to the employment of the Portsmouth City Teaching PCT.
  - (3) The contract of employment of an employee transferred under paragraph (2)—
    - (a) is not terminated by the transfer; and
    - (b) shall have effect on and after 1st October 2006 as if originally made between that employee and the Portsmouth City Teaching PCT.
  - (4) Without prejudice to paragraph (3)---
    - (a) all the rights, powers, duties and liabilities of the old PCT under, or in connection with, a contract to which that paragraph applies shall, by virtue of this article, be transferred to the Portsmouth City Teaching PCT on 1st October 2006;
    - (b) anything done before that date by or in relation to the old PCT in respect of that contract or that employee shall be deemed on and after 1st October 2006 to have been done by or in relation to the Portsmouth City Teaching PCT.
- (5) Paragraphs (2) and (3) are without prejudice to any right of any employee to terminate his contract of employment if a substantial and detrimental change is made to that employee's working conditions, but no such right shall arise by reason only of the change of employer effected by this article.

- (6) Paragraphs (2) and (3) do not transfer an employee's contract of employment, or the rights, powers, duties and liabilities under or in connection with it, if that employee has objected to the transfer to the Portsmouth City Teaching PCT and had informed the old PCT of that objection on or before 30th September 2006.
- (7) Where an employee has informed the old PCT of his objection as mentioned in paragraph (6), his contract of employment with the old PCT shall be terminated immediately before the date on which the transfer would occur, but he shall not be treated, for any purpose, as having been dismissed from the old PCT.

## Transfer of staff to the Portsmouth Hospitals NHS Trust

- 4.—(1) This article applies in relation to any person who—
  - (a) was an employee of the old PCT immediately before 1st October 2006;
  - (b) was employed immediately before 1st October 2006 to work at the premises identified in the Schedule to this Order; and
  - (c) has been notified in a letter posted on or before 1st September 2006 that he is to be transferred to the employment of the Portsmouth Hospitals NHS Trust.
- (2) Any person to whom this article applies shall on 1st October 2006 be transferred to the employment of the Portsmouth Hospitals NHS Trust.
  - (3) The contract of employment of an employee transferred under paragraph (2)—
  - (a) is not terminated by the transfer; and
  - (b) shall have effect on and after 1st October 2006 as if originally made between that employee and the Portsmouth Hospitals NHS Trust.
  - (4) Without prejudice to paragraph (3)---
  - (a) all the rights, powers, duties and liabilities of the old PCT under, or in connection with, a contract to which that paragraph applies shall, by virtue of this article, be transferred to the Portsmouth Hospitals NHS Trust on 1st October 2006;
  - (b) anything done before that date by or in relation to the old PCT in respect of that contract or that employee shall be deemed on and after 1st October 2006 to have been done by or in relation to the Portsmouth Hospitals NHS Trust.
- (5) Paragraphs (2) and (3) are without prejudice to any right of any employee to terminate his contract of employment if a substantial and detrimental change is made to that employee's working conditions, but no such right shall arise by reason only of the change of employer effected by this article.
- (6) Paragraphs (2) and (3) do not transfer an employee's contract of employment, or the rights, powers, duties and liabilities under or in connection with it, if that employee has objected to the transfer to the Portsmouth Hospitals NHS Trust and had informed the old PCT of that objection on or before 30th September 2006.
- (7) Where an employee has informed the old PCT of his objection as mentioned in paragraph (6), his contract of employment with the old PCT shall be terminated immediately before the date on which the transfer would occur, but he shall not be treated, for any purpose, as having been dismissed from the old PCT.

## Enforceability and transfer of rights

- 5.--(1) Any right which---
  - (a) was enforceable by or against the old PCT immediately before 1st October 2006; and
  - (b) is not referred to in article 2, 3 or 4;
- shall on 1st October 2006 be transferred to the new PCT and on and after that date shall be enforceable by or against that PCT.
  - (2) In paragraph (1), "right" includes any right in relation to trust property held by the old PCT.

#### Transfer of liabilities

- 6.—(1) All liabilities to which the old PCT was subject immediately before 1st October 2006 which—
  - (a) are not referred to in article 2, 3 or 4; and
- (b) are identified as a liability in the Portsmouth Hospitals NHS Trust Transfer Schedule: shall on 1st October 2006 be transferred to the Portsmouth Hospitals NHS Trust.
  - (2) All other liabilities-
    - (a) to which the old PCT was subject immediately before 1st October 2006; and
  - (b) which are not referred to in article 2, 3 or 4 or in paragraph (1);

shall on 1st October 2006 be transferred to the new PCT.

(3) In paragraph (2), "liabilities" includes any liabilities in relation to trust property held by the old PCT.

#### Transfer of property

- 7.—(1) All property held by the old PCT immediately before 1st October 2006 shall on 1st October 2006 be transferred to the new PCT.
  - (2) In paragraph (1), "property" includes trust property.

#### Determination of doubt

- 8.—(1) If there is any doubt as to which transferee a liability is transferred by article 6, the transferees shall agree the matter between themselves.
- (2) If the transferees are unable to agree the matter between themselves, the South Central Strategic Health Authority shall determine the matter.
