- We can confirm that the Portsmouth and South East Coroner has initially reported the facts about seven deaths which occurred at Gosport War Memorial Hospital over a number of years, where the bodies had been cremated

Inquests taking place where bodies have not been cremated:

 If a body is buried in the coroner's district it is for him to consider under section 8 of the Coroners Act 1988 whether he has a duty to hold an inquest.
