1 Apologies for Absence

2 Notes of the Meeting held Wednesday 22 October 1997

These were agreed.

3 Variation in practice-based Physiotherapy referral rates (Attached)

HJ tabled figures detailing the referral rates to the Gosport War Memorial Physiotherapy department from practices using the service (note: Dr Dow & partners are not shown as they refer to Hill Park, Fareham). The tables and graphs highlighted considerable variation in referral rates, together with an overall rate for the locality that exceeded current Health Authority funding. HJ explained that additional funding was unlikely as other areas within the HA currently had lower levels of resources and therefore additional resources in order to bring them up to the level for Gosport.

HJ also explained that Haslar had provided some practice-based figures, but they had not been circulated as they contained errors with some individual GPs recorded as being from the wrong practices.

FS questioned whether contacts could be used as apposed to referrals in order to record the activity. FS explained that this would take account of different types of referrals requiring greater input and therefore more resources eg a patient with back pain was likely to take longer to treat than a patient requiring a simple splint and yet they would both be recorded as one referral. WM agreed to provide figures based upon contacts and HJ agreed to circulate these in the same format as that used to show referrals.

4 Practice-based waiting lists

(Possible way towards more equitable access amongst practices)

Given the increasing waiting times, lack of additional money and variable referral rates, it was agreed that practice-based waiting lists offered an equitable way of addressing the current problem. Both WM and IL agreed that the model could easily be set up and managed and IL agreed to circulate advice/information that should assist GPs in prioritising their referrals. HJ explained that such a model would not prevent GPs from referring patients to the service, but it would ensure that those practices with high referral rates would not adversely affect the waiting times of practices referring at lower rates. IL also explained that the practice-based waiting times would be for routine patients and therefore not affect treatment of urgent patients.

JB asked how many patients were on the current waiting list and questioned how the setting up of a practice-based waiting list would take account of these. IL replied that 380 patients were currently on the list and HJ agreed to pursue the idea of additional non-recurring resources being made available by the HA in order to clear the current waiting lists prior the project starting. It was therefore agreed that subject to this occurring, practice-based waiting lists would be piloted and the target date for commencement was 1 January 1998. (Post meeting note: additional resources have been made available as part of a package to reduce the current waiting lists prior to the project starting).

It was also agreed that WE, DH and SH would meet to discuss Haslar's role in this pilot and to ensure that all GP physiotherapy referrals were counted against the practice-based waiting times.




GP practice physiotherapy referrals to GWM
