At the recent Gosport GP Steering Group, the notes of which are attached, discussion took place on the potential for local GPs to take a more direct role in the prioritisation and decision making process to allocate resources for district nurses, health visitors and practice nurses. Many practices believe that inequalities exist within these areas and GPs are well placed to formulate a more equitable distribution, along with an acceptable plan of action. Whilst the Health Authority (HA) and HealthCare Trust (PHCT) can and have been making such decisions based upon the available information, input from GPs may help to improve this process and GPs often have qualitative information not recorded elsewhere. In order to achieve this, agreement is required from each participating practice that the Gosport GP Steering Group can share practice-based information held by PHCT and the HA.

A similar debate took place regarding the provision of and access to physiotherapy services and it was again decided that agreement be sought to share this data at practice level.

I would therefore be grateful if, on behalf of your practice, you could indicate on the attached form whether you are willing for this data to be shared at the Gosport GP Steering Group.
