I had put my patient on the urgent list for a Summervale transfer but that would clearly not be appropriate if Mr. K. moves to Summervale.

As I have said on many occasions before, Collingwood- and possibly Ark Royal too?- needs some urgent staff development. The EMH Service here in F+G feels like a service in decline (see my previous e-mail) which makes me want to weep!

I shall obviously liaise with Janet but won't be in now until Tues am. Have a good W/E
