Tel call to DS Paul Clark.

- * John James wrote to me on 6 July re - reviewing 4 other sets of records. Paul will put another copy in post.

This letter does not give details of next of kin. We agreed that he & I would discuss NOK when I have medical records. The police family contact of our NOK might not be the same.

- * Brian Cunningham - details confirmed. Complaint to police is son: Mr Farthing D.O.B. = **Code A**. Death 26/09/1998 address on admission: THAHASSA, (Nursing Home) 79 Weston Way, Alvestoke. Death Certificate by Dr Brook

- * The police have not yet contacted relatives to advise about current enquiries. They are anxious about raising false expectations. There is no suggestion at this stage that further enquiries / prosecution will follow.
