From <u>Code A</u> questions of me, interest lies in the prescription for S/C diamorphine; 40 - 200 mgs in 24 hours - I was asked how/which nurses would decided how much to give. An academic question as only 40 mgs in 24 hours was ever given - and this is borne out by the controlled drug register. Interest also in midazolam and the police will be exploring with pharmacy what pharmacuitical company manufactured and supplied and what this drug was registered for in August 1998.

The investigaiton will begin with interviews of all nursing staff who were on the estblishment for Daedelus in July/Aug 1998 -trained and untrained. If there were agency/bank staff working on the ward during the period Mrs R was a patient then they would be interviewed two. Second stage will be interviews with Philip Beed - as ward manager, and probaly Barbara Robinson as Service Manager. Third stage will be interviews with doctors; Lord/reid/Barton/Peters/Briggs.

Staff will be contacted by police at home and offered interview in own home, at GWMH or in police station if they wish. Fiona and I have agreed that staff should be given time off/time in lieu to attend these interviews.

Thats about it. I will be in touch with some off you to confirm some specific details.
