Information supplied by Hampshire Constabulary

You will see in the enclosed report (pages 3 and 4) that reference is made to the police supplying files to the NMC. There are approximately 185 box files, the contents of which are of differing sizes. It is open to the RCN to see the contents of the files, but it is not possible, due to the volume for them to be copied and sent out. A mutually convenient date could be met for you to view them in advance of the meeting.

Employment reference
