When I came to start work on this case in June 2009, this is the TRIM file which had the most information under it and, for the sake of coherence, the one reference which I have used in all correspondence.

In all future dealings, as we have the freedom not to assign individual case references to the registrant (as 93 Rules cases are not stored in TRIM) I would propose to use a variation on the number/individual practitioner, ie Code A

Employment references: Hampshire Community Health Care Trust has yet to respond to my request for references, sent on 12 January 2010. I know that when we met last year there was going to be a problem with collating them as the referees were working at various sites. We are expecting three and if nothing is received by Friday, I will telephone Sue Harriman.

Portsmouth Hospitals NHS Trust have been asked to provide four references and have, so far, provided two this week.

GMC: on Monday afternoon, Scott Geddes (Head of Adjudication Standards and Fitness to Practise) sent over the decisions and reasons from the hearing. This has been saved in TRIM under the working folder 12053. This was followed on Tuesday by the outstanding transcripts and saved in TRIM under the appropriate folder. He has confirmed that there is no objection to the disclosure of the transcripts.

I'll start further work on this today/tomorrow and am likely to come back to you on the allegations, particularly [Code A] When we have something from [Code A] 2009 with [Code A] and Ian so that we can agree some common ground about how we proceed.
